

ORDINANCE NO. 3831

AN ORDINANCE PROVIDING FOR A STOP SIGN ON EAST MILL STREET AT ITS INTERSECTION WITH EDWARDS STREET BY AMENDING SCHEDULE I STOP INTERSECTIONS AND SCHEDULE II YIELD INTERSECTIONS OF CHAPTER 77 TRAFFIC SCHEDULES, OF TITLE 7 TRAFFIC CODE OF THE CITY CODE, AND DECLARING THAT THIS ORDINANCE SHALL BE IN FULL FORCE AND EFFECT IMMEDIATELY UPON ITS PASSAGE AND APPROVAL AS PROVIDED BY LAW.

WHEREAS, After receiving a request from an area resident and observing of typical traffic patterns at the intersection of Mill Street and Edwards Street, Kewanee's Chief of Police has made a recommendation to replace the existing YIELD Sign by installing STOP signs on Mill Street at its intersection with Edwards Street due to the limited visibility of the intersection; and,

WHEREAS, Mayor and City Council hereby accept the recommendation, and find it to be in the best interest of motorist and pedestrian safety to replace the existing YIELD signs with STOP signs on Mill Street at its intersection with Edwards Street.

NOW, THEREFORE BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF KEWANEE, ILLINOIS, IN COUNCIL ASSEMBLED, AS FOLLOWS.

SECTION ONE: Schedule I "Stop Intersections" of Chapter 77 Traffic Schedules of the City Code shall be, and hereby is, amended by inserting the underlined words (sample) shown below in the appropriate alphabetized location:

Intersection	Corner
<u>Mill Street and Edwards Street on Mill Street</u>	<u>Northeast</u>
<u>Mill Street and Edwards Street on Mill Street</u>	<u>Southwest</u>

SECTION TWO: Schedule II "Yield Intersections" of Chapter 77 Traffic Schedules of the City Code shall be, and hereby is, amended by deleting the struck through words (~~sample~~) - shown below in the appropriate alphabetized location:

Intersection	Corner
Mill Street and Edwards Street on Mill Street	Northeast
Mill Street and Edwards Street on Mill Street	Southwest

SECTION THREE: This Ordinance shall be in full force and effect immediately upon its passage and approval as provided by law.
