

**RESOLUTION NO. 4962**

A RESOLUTION TO ISSUE A NOTICE OF AWARD, ATTACHED HEREWITH, AND AUTHORIZING AN AGREEMENT WITH LEANDER CONSTRUCTION, INC. OF CANTON, ILLINOIS FOR THE WWTP CLARIFIER UPGRADES PROJECT AND DECLARING THAT THIS RESOLUTION SHALL BE IN FULL FORCE IMMEDIATELY.

**WHEREAS,** The fiscal year 2016 municipal budget, at line item 33-49-532/850, contains funding for the WWTP Clarifiers upgrades; and,

**WHEREAS,** Chamlin and Associates, Inc. prepared plans and specifications and advertised for bids; and,

**WHEREAS,** Six bids were received and opened on February 4, 2016. The bids received were as summarized in the table shown below and further itemized on the attached tabulation of bids; and,


