

RESOLUTION NO. 4978

A RESOLUTION TO AUTHORIZE USE OF VARIOUS CITY STREETS, PARKING LOTS AND GREEN SPACES BY THE HOG CAPITAL BARBECUE, INC. FOR THE 2016 HOG CAPITAL OF THE WORLD FESTIVAL, AND DECLARING THAT THIS RESOLUTION SHALL BE IN FULL FORCE IMMEDIATELY.

**Whereas,** The City of Kewanee has received a request from the Hog Capital Barbecue, Inc. requesting use of various municipal streets, parking lots and green spaces in connection with the 2016 Hog Capital of the World Festival, scheduled for September 2, 2016 through September 5, 2016; and,

**Whereas,** City of Kewanee staff has discussed the request with the Hog Capital Barbecue, Inc., and both parties have agreed upon the areas to be used and the duration of said use; and,

**Whereas,** The City Council expresses its gratitude and continuing support of the Hog Capital Barbecue, Inc. in producing this annual festival and acknowledges all the benefits derived from it in the City.

NOW THEREFORE BE IT RESOLVED, BY THE COUNCIL OF THE CITY OF KEWANEE THAT:

**Section 1** The City Council hereby grants permission to Hog Capital Barbecue, Inc. to use the following public streets, parking lots and green spaces for the time periods specified:


- A. West Park — Food concessions only, Thursday noon. All other users Friday morning through Monday for flea market/craft show.
- B. Berrien Park at 200 W. Third St. — Monday Noon through Wednesday noon, north fifty feet (50') of site only. Wednesday noon through Monday for carnival and concessions.
- C. Parking lot in 200 block of W. Second St. — Thursday 5PM through Monday for equipment parking.
- D. Parking lot west of 200 W. Third St. — East half of lot only, noon on Monday for carnival trucks. Remainder of lot, Wednesday 12:01 AM to following Monday for carnival. Amtrak parking lot is not included in this permission and will remain open to Amtrak users.
- E. Two parking lots in 100 block of W. Third St. — Wednesday 12:01 AM to Monday for carnival.
- F. Parking lot in 300 block of N. Main Street — Friday 4PM to Monday for festival volunteer parking.
- G. Parking strip north side of Loomis Street — Monday noon to following Monday for carnival campers.
- H. 200 block of W. Second Street — Thursday 5PM to Monday, food vendor and concessionaire set-up and vendor parking only in on-street parking spaces.
- I. 100 block N. Tremont Street, from just north of Union Federal Savings & Loan ATM drive thru exit — Thursday 5PM to Monday, US Army Recruiting Display, model T and model A parking, Miller Family Farms Petting Zoo Trailer.

- J. 200 block of N. Tremont Street — Thursday 5PM to Monday, carnival and concessions, maintaining access to PNB until noon on Saturday.
- K. 300 block of N. Tremont Street — Thursday 12:01 AM to Monday, carnival and concessions.
- L. 100 block of W. Third Street — Thursday 12:01 AM to Monday, carnival and concessions.
- M. 200 block of W. Third Street — Thursday 12:01 AM to Monday, carnival and concessions, maintaining access to Station House parking lot and the loading dock.

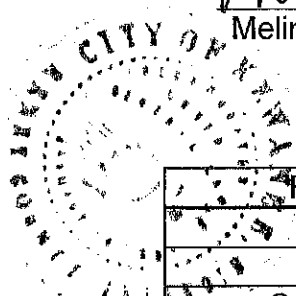
**Section 2** This Resolution shall be in full force and effect immediately upon its passage and approval as provided by law.
